Terms & Conditions:

1. The vehicle will be hired w.e.f. from 15/05/ 2014 to 23/03/2015. The period will be extended upto 14/05/2015 subject to getting approval from CEA, New Delhi.
2. The rates are inclusive of all duties, taxes and other charges etc.,
3. The vehicle will be parked at the office of SRPC premises and will be at the disposal of SRPC office.
4. SRPC is not responsible for any kind of expenditure arising out of all kinds of emergencies like accidents/breakdowns/maintenance.
5. All regulatory requirements viz. insurance, Taxes have to be fulfilled during the contract period and non compliance is liable for cancellation of the contract.
6. The maintenance and all related expenses of the vehicle will be the sole responsibility of the supplier during the contract period.
7. During routine maintenance/emergency breakdowns/accidents/unforeseen circumstances, alternate vehicle will be provided immediately during the absence of regular vehicle. Non availability of alternate equivalent vehicle during maintenance will be treated on par with unavailability of the vehicle and proportionate deductions in the monthly payments will be effected.

8. The vehicle will be driven by staff car driver posted at SRPC
9. Fuel charges for the hired vehicle will be borne by SRPC, Bangalore.
10. The income tax will be deducted at source as per the prevailing rules/norms.
11. The period of contract may be extended on the same finalized Terms and Conditions for a further period of one year.
12. SRPC reserves the right to cancel contract and alter the terms and conditions for any reasons if the service is found unsatisfactory.
13. The terms & conditions mentioned in the tender document are also applicable and forms part of this order.
14. Any dispute arising on account of interpretation of rules of terms and conditions will be referred to the Member Secretary, SRPC and his decision will be final.
